GUIDELINES TO MEMBERS

- Be at least 18 years of age or over.
- Be a member in good standing of PECU Credit Union Cooperative Society Limited.
- Be a member in good standing of any other credit union in which you are a member.
- Should not be an Officer of the Board of Directors, Credit Committee or Supervisory Committee, a General Manager or Internal Auditor of another Credit Union.
- Shall not be employed or in receipt of a salary/ wage from PECU Credit Union Cooperative Society Limited
- Be of sound mind.
- Not be declared bankrupt or apply for bankruptcy.
- Not be convicted of an offence involving dishonesty.
- Not be involved in a lawsuit against PECU Credit Union Cooperative Society Limited.

Submission of Nomination Packages

Nomination packages must have all fields completed and deposited in specially marked boxes located at the offices of PECU Credit Union Cooperative Society Limited located at Port of Spain, and Tobago. Each nomination should be submitted in a sealed envelope by the deadline to be determined by the Nominating Committee addressed to:
